

Step One: Intake/Admission

- Collect all required documents related to child and present to the appropriate authorities
 - **India:** Present JJA Form 17 to CWC within 24 hours
- If child was lost or abandoned, notify Police or other authorities
 - **India:** CCI must submit Form 17 to Local Police

Child placed at CCI

Step Two: Assessment

- Identify child's concerns to be addressed and complete a Child Care Plan
 - **India:** Child Case History - JJA Form 43 and Individual Care Plan (ICP) - JJA Form 7 within one month
- Determine if reintegration is possible after contact with family
 - **India:** Social Investigation Report (SIR) – JJA Form 22 within 15 days
- Complete Home Thrive Scale™ to identify Red Flag safety issues, and determine feasibility of permanent reintegration

Child Remains in CCI

- Explore alternative care options (e.g. foster care, adoption, semi-independent living)
- If option becomes available, go to Step Three: Planning
- **India:**
 - Repeat SIR annually
 - Review ICP Part B monthly
 - Update Track Child Portal monthly

Step Four: Implementation

- Complete Home Thrive Scale™ after home visit to reassess safety if family had Red Flag concerns, and to ensure early critical interventions have been successful (Ideally within 1 month but no more than 3 months prior to reintegration)
- **India:**
 - Complete ICP Part C 15 days prior to reintegration
 - Repeat SIR if most recent was completed more than 3 months ago
- Move child after several short stays in new living situation
- Continue to provide support to child and family as outlined in the Home Thrive Scale™

Step Three: Planning

- Child focused decision making – Multi-disciplinary Team (MDT) discussion regarding placement: family, foster care, independent living, etc.
- Utilize Home Thrive Scale™ to detail necessary interventions
- Prepare child and family for reintegration
- **India:**
 - Update ICP Part B on monthly basis while child is in CCI
 - Present finding of assessment/recommendation to CWC

Disruption in Placement

- **Move to emergency foster care, kinship care, respite care, etc whenever possible**
- **Return to CCI only as last option**
- **If child is returned to CCI, start case management process at Step One.**
- **India: present case to CWC with supporting reports**

Step Five: Follow Up and Evaluate

Calls	Visits
1 st month- weekly	1 st month

6 th month - 1.5 years- quarterly	6 th month

- Complete Home Thrive Scale™ at follow up visits to ensure safety, overall well being and progress in areas needing support.
- **India:** Complete ICP Part D at 1st follow up visit
